- Acquisition and preservation of historic buildings and landscapes

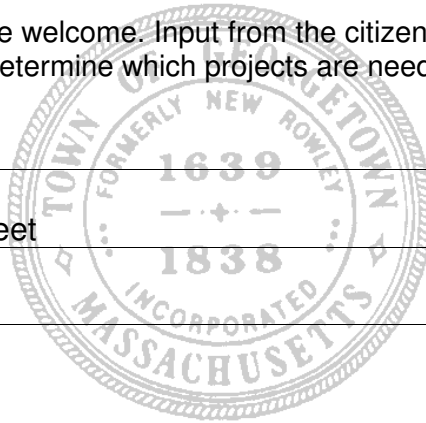
The three core concerns provide guidelines for the use of CPA funds. Projects must meet specific legal requirements to be eligible for funding by the CPA.

### Suggestion:

Based on the July 31<sup>st</sup> letter receive by the New Life Community Church (attached) and the additional letter received by James Tolman, I would like to suggest that the town negotiate the sale of the two parcels (or portions of these parcels) and the right of way necessary to access the 11 acre parcel donated by Jim Bussing. This access may also require of negotiating with United Foam to purchase additional land if the Conservation Commission deems said purchase a necessary condition to access the property.

Before the final purchase of these parcels, I would also recommend that wetland delineation be done by the CPC for the portions of the parcel that would require motor vehicle parking. Upon review of this delineation, I would recommend that before this purchase is allowed that the Conservation Commission give opinion to the town on likelihood of necessary motor vehicle parking based on the delineation.
